CUSTOMS AREA IS AN AREA DESIGNATED FOR STORAGE OF COMMERCIAL GOODS THAT HAVE NOT YET CLEARED CUSTOMS. IT IS SURROUNDED BY A CUSTOMS BORDER.

INTERNATIONAL  
AIRPORTS AND  
HARBOURS HAVE  
DESIGNATED  
CUSTOMS AREAS,  
SOMETIMES  
COVERING THE  
WHOLE FACILITY  
AND INCLUDING  
EXTENSIVE STORAGE  
WAREHOUSES.**



**WHILE  
TERRITORIALLY  
PART OF THE  
COUNTRY OF THE  
CUSTOMS  
AUTHORITIES,  
GOODS WITHIN  
THE CUSTOMS  
AREA HAVE NOT  
TECHNICALLY  
ENTERED THE  
COUNTRY YET,  
AND MAY LATER  
BE SUBJECT TO  
CUSTOMS DUTIES.**

**THE GOODS WITHIN  
THE AREA ARE ALSO  
SUBJECT TO CHECKS  
REGARDING THEIR  
COMPLIANCE WITH  
LOCAL RULES (FOR  
EXAMPLE DRUG LAWS  
AND BIOSECURITY  
REGULATIONS), AND  
THUS MAY BE  
IMPOUNDED OR  
TURNED BACK.**

CAREFULLY  
CONTROLLED  
AND FENCED.**

**THE FACT THAT  
GOODS ARE

COUNTRY OF THE  
CUSTOMS AREA  
ALSO ALLOWS EASY  
TRANSSHIPMENT  
TO A THIRD  
COUNTRY WITHOUT  
THE NEED FOR  
CUSTOMS CHECKS  
OR DUTIES.**


